'Rebels' story missed campaign reform

To the editor:

Several weeks ago Daymond Steer wrote an article "Rebels with Causes" in which he detailed the distrust and anti-government sentiment as illustrated in the actions/of several individuals.

This front page story of 1,500 words or so missed a whole class of "rebels with a cause" that is worth a mention here. I'm talkspecifically the actions of concerned citizens in over 50 New Hampshire communities who voted this last town meeting cycle on resolutions much like the one that passed easily in Conway the previous year.

Therefore, throughout the country, in a manner similar to New Hampshire, people are saying "enough!"
